CODE OF CONDUCT – PARENTS/CARERS

Good practice for parents

Parents should be encouraged to accompany their children to activities, but they should not be included in supervision calculations unless they are present in an official volunteering role. This Parents' Code of Conduct gives everyone a guide to what is expected of parents if they are part of an organisation, participating in a sport, or are spectators at their child's events. Ethics in sport are embodied in the following principles: respect, responsibility, fairness, caring, trustworthiness and good citizenship.

This Code of Conduct asks parents to respect the following guidelines:

- Encourage your child to skate in a safe and healthy environment.
- Encourage good sportsmanship by demonstrating positive support for all skaters, coaches, volunteers and officials and do not question the judgement of event officials.
- Emphasise that doing one's best is more important than winning. Teach that effort and participation are as important as victory.
- Do your best to make skating fun and remember that your child participates in sports for his/her own enjoyment – not yours. Do not force them to participate unwillingly.
- Advise your child to treat other skaters, coaches, officials and rink staff with respect. Treat them as you would wish to be treated.
- Advise your child to treat everyone equally and sensitively regardless of their age, disability, gender, race, ethnic origin, cultural background, sexual orientation, religious beliefs or political affiliation.
- Inform your child's coach of any disability that may affect the safety of your child or the safety of others.
- Place the emotional and physical well-being of your child ahead of your personal desire to win.
- Support all efforts to remove all forms of verbal and physical abuse from ice skating.
- Remember that young people and vulnerable adults learn best by example.

As a parent/carer you have the right to:

- Be assured that your child is safeguarded during their participation in sport.
- Be informed of problems or concerns relating to your child.
- Be informed if your child is injured.
- Have your consent sought for participation in events, trips and competitions.

- Have your consent sought for participation in film or photography.
- Contribute to decisions within the Club.
- Have any concerns about any aspect of your child's welfare listened to and responded to.

As a parent you are expected to:

- Complete and return the Membership form and the Photo Consent form and Health Declaration pertaining to your child's participation with the Club.
- Be responsible for ensuring your child arrives and is collected punctually before and after sessions/competitions/events. Where your child is under the age of 12 remain rink-side during the session/competition/event. Where your child is under 16 remain in the building/locality during the session/competition/event.
- Ensure your child has appropriate kit and clothing. Any child not in possession of the fundamental safety requirements will not be permitted to participate.
- Detail any relevant medical concerns or conditions pertaining to your child on the registration/consent form. Any changes in the state of your child's health should be reported to the coach or Club staff prior to any activity.
- To inform the coach prior to the activity starting if your child is to be collected early.
- Encourage your child to play by the rules, and teach them that they can only do their best.
- Ensure that your child understands their Code of Conduct.
- Behave responsibly whilst spectating; do not embarrass your child.
- Show appreciation of and support for the coach.
- Be realistic and supportive.
- Accept the decisions of coaches, judges and other officials.
- Respect the use of the Club and Spectrum facilities.

Any breaches of this Code of Conduct will be dealt with immediately by a Designated Person. Persistent concerns or breaches may result in you being asked not to attend training sessions, competitions or any other event organised by the Club if your attendance is considered detrimental to the welfare of young participants.

The ultimate action should a parent/carer continue to breach the Code of Conduct may be the Club regrettably asking your child to leave the session, event or Club.
